Members of the City of Lexington Boards and Commissions shall hold office until their successors are appointed and qualified. It shall be unlawful for any member to serve for more than two (2) consecutive three-year terms, without an intervening period of three (3) years, unless designated otherwise. Members of the City of Lexington Boards and Commissions shall serve without compensation unless otherwise approved by the City Council. (Ref. City Code, Article V., Section 2-171, 2-172.)
